POLICE REPORT

I, Hanskoemar MOHAN, officer first class with the Aruba Police Force and assigned to investigation district 2 declare the following

On June 29 2005, per request of the District Attorney Mr. K. P. J JANSEN, an audio CD was reviewed by me, MOHAN, on which a conversation between D.KALPOE, S. KALPOE en J v/d DE SLOOT was recorded

The names of the aforementioned speakers will be indicated in this police report with the following letters:

- D.KALPOE is indicated as TT. **D**
- S.KALPOE is indicated as 'S'
- J v/d SLOOT is indicated as 'J'

The conversation on the audio CD was held in Dutch and was transcribed by me, Mohan, and contains the following.

D says to J "how does it feel Joran"

J says to D with a raised voice "you have got my 'father arrested friend"

D says, very calmly, to J "that's what I say, how does that feel"

J says to D "you know very well that my father had nothing to do with it"

J says to D "I've read your test many friend"

D says to J "that is bullshit"

J says to D "you are lying shit"

J says very calmly to D "you know what happened to that girl, if you don't know then nothing has happened to her".

J says to D "so fuck you"

J says to D "What are you saying that Freddy has to be arrested"

D says to J "that Freddy must tell the truth"

J says to D "you know very well that Freddy has told the truth"

S says to J "you are going to see, you are going to see"

D says to J "you could've prevented this from the beginning. that about your father"

D says to J "you know it"

J says to D "how what, how war"

D says to J "that he was not arrested"

J says to D "how hooooooooow"

J says to D "you're testifying shit against him"

J says to D "my father only wanted to help you friend"

J says to D "just to help you that is all my father wanted. My father even arranged your attorneys"

J says to D "and this is how you're paying it back"

J says with an angry voice to D "I should punch both of you"

D says to J "go ahead try it"

D says to J "you can make it right in one shot, you know it"

J says to D "about what"

J says to D "you can also make it right"

J says to D "how make it right"

D says to J "you just have to tell the truth"

O says to J "tomorrow I get my last 8 days and after that I am going home"

J says to O "that's what you think"

D says to J "I am going home"

J says to D "just wait till I start saying things about you"

J says to O then I want to see whether you'll go home"

O says to J "I guarantee you"

J says to O "don't you think that the police is interested to know that Satis hit a girl with the car"

S says to D "he heh and you make me laugh boy, just laugh"

D says to J "you know damn well you always try to bring bulshit between us"

J says to D "then you go talking shit about the ChoHer"

J says to D "I helped you with that shit about the cholter* friend"

D says to J "I also said that"

J says to D "I didn't read it like that, tfo read that testimony too"

S says to J "that about the cholters* was from me"

D or S says to J "I had already said that earlier"

D or S says to J "I also said that in my first testimony"

I did that for myself.

S says to J "I said it in my interest"

J says to S "who said that"
S says to J "you said that"
J says to S "I never said that friend"
J says to S "I never said that you've been back friend"
J says to the brothers "that is your problem"
J says to the brothers "if they all find that girl then they will see that shit"
D says to J "eight more days and then I am going home, I guarantee you that 1000 percent"
J says to D "then we will see"
D says to J "you just don't give a shit about your own family members"
J says to D "the only thing I can think about is my family, I do what my family tells me to do"
J says to the brothers "huh mongol"
D says to J "simply your own father, unbelievable"
J says to D "what about my father, it is your fault that he got arrested. I did not testify anything against my father, you testified against my father"
S says to J "we testified nothing"
J says to the brothers "of course you did"
S says to J "what did I say against your father"
J says to the brothers "you're sitting there saying that he testified, that if there is no corpse, there is no case or what do I know what all kinds of shit"
J says to the brothers "that is not true at all, the only thing he said is if there was no body that then there is no case"
D says to J "that is true"
J says to D "none of that is true"
D says to J "I also said in my testimony that it wasn't meant like that"
J says to D "20 I did not read it in your testimony"
J says to the brothers "that's what they're using against my father now"
D says to J "we have suffered a lot through you"
J says to the brothers "that's the price that you have let my father pay. That you let him suffer like that, fuck you. If you let me suffer, that is what I am saying too. It does not bother me at all I can simply sit here 180 days, it does not make a damn bit of difference to me. I am fine here"
Brothers say to J "me too me too"
J says to S "and you Satish, they're telling me that you, jerk, see ghosts in the cell"
J says to S "they have told me that you saw the girl in your cell and that you were scared stiff"

S says to J "I was seeing ghosts? Two other guys were seeing ghosts"
S says to J "you also believe the people that are sitting in jail here"
S says to J "that has nothing to do with ghosts and that is rubbish shit what you're saying"
J says to S "they talk good about me, but not good about you"
J says to the brothers "and also the two guards, they have guaranteed me that they will kill you if you get out of jail."
D says to J "oh yes"
J says to the brothers "who gave testimony about the guards, you and not me. Why? Because I did not want to get anyone in trouble who has nothing to do with this case"
D or S screams at J "that lie was for you"
J says to the brothers "you admitted that"
D or S screams at J again "that lie was for you"
J says to the brothers "you paid him off after all"
Brothers laugh "hahahahahahahaha"
J says to brothers "you then called on the phone, like that I have the jackpot. You said over the phone, I have the fucking jackpot. You forget that the phone is wiretapped huh".
S or D says to J "shut your trap"
J says to the brothers "you forget that, huh mongo"
J says to the brothers "then you come home and you say now you then arranged everything. You say "I fixed it"
J says to D "good for you. Because of you nif is sitting in the slammer too"
D says to J "aaaaaaaiyyaaiyarar"
J says to the brothers "Fuck you man what are you going to be able to do"
D says to J "what are you going to be able to do"
J says to the brothers "make me keep my mouth shut no"
brothers say to J "fuck you we are not talking to you any more"
D says to J "you talk till you get tired"
S says to D "do you have clothes"
D says to J "what am I going to do with that I'm going to be leaving overfi days anyway"
J says to D "that's what you think"
D says to J "shut your mouth"
D again says to J "shut your trap you bitch"
J says to D "what are you going to be able to do"

J says to the brothers "half of what you have said is not the fucking truth"

J says to the brothers "it will come to the fore"

J says to the brothers "just as they check me they check you too."

S says to J "with us, with us. They can get evidence, but not with you."

S says to J "and with lies you don't get evidence"

J says to the brothers "all that shit about "Karen" all of you don't know about shit"

J says to the brothers "fuck you"

D says to J "you think that the girl has nothing on, you'll see who fucked who (this sentence was not clearly intelligible)"

J says to D "then we will see"

J says to D "hey you know when I will laugh, when I have given you a smack in the face"

J says to D "I will laugh if they find the girl alive, fuck you"

J says to the brothers "I know very well that you are afraid"

 J says to D "Do you think that makes any difference to me. One blow will be enough"
 S says to J "you think, you think"
 J says to S "what do you think, that you're going to go home to pick up your pistol"
 S says to J "that I have a pisto"
 J says to S "Satis you, get a pistol at home. I shoot you dead"
 S says to J "look the police already went to my house and they have also already searched the house. Did they find a pisto?"
 S says to J "what will she get"
 D says to J "you sometimes talk bullshit huh"
 J says to D "why is that shit not true, witnesses have seen you"
 S says to J "in the end we will see who gets out and who stays"
 S says to J "you speak the truth, we will see" J says to brothers
 "I know I'll get out" Brothers say "we shall see hahahaha"
