That the foregoing offense(s) alleged was committed of this affiant's own personal knowledge, and the facts stated therein

Your Affiant interviewed Wade Alan Frank, a student of Columbine High School, who stated that about 11:30 a.m., lunch time, he was in the parking lot of Columbine High School with Tyler Jackman, when he heard gunshots inside the school. Wade Frank saw a male wearing a long black trench coat at the top of the stairs at the entrance to Columbine High School. Wade Frank mentioned to Jackman that he thought it was Jackman told Frank it was Dylan Klebold. The male in the trench cont was also wearing a black hat, possibly a baseball hat backwards or a ski mask. Wade Frank saw the πale walk down the stairs, approach a male lying face down at the bottom of the stairs, and shoot a sawed off shotgun into his back. Wade Frank saw the male throw a white PVC pipe bomb, which exploded. Wade Frank saw the male walk to the top of the stairs, where there was a second male dressed the same.

Arapahoc County Sheriff's Detective Faith Stevens interviewed Columbine High School teacher Peggy Dodd. Dodd stated that she was in the library of Columbine High School when a student, Brian Anderson, entered the library and fell against the counter. Peggy Dodd stated that Brian Anderson had blood on his face and chest. Brian Anderson stated, "Eric Harris shot me." Peggy Dodd stated she looked outside and saw Dylan Klebold standing on a grassy knoll above the parking lot. Peggy Dodd stated that Klebold was carrying a long rifle type gun, shooting into the parking lot in a sweeping motion.

On April 20, 1999 Jefferson County Sheriff's Investigator Don Estep and FBI Special Agent Mark Holstlaw interviewed Robert Perry, in the presence of his parents, James and Lydie Perry. Perry stated he dropped out of Columbine High School a couple of months ago. He stated that he became associated with Eric Harris and a male known only to him as Dylan, during the latter part of the last school year. Harris and "Dylan" were becoming associated with the Trench Coat Mafia at that time and were good friends of Trench Coat Mafia leader, Chris Mortis. Perry stated the last contact he had with either Harris or Dylan was in about "nuary 1999, outside of Columbine High School. Perry stated he wears an all-cotton black trench coat. Perry stated that he ped associating with Trench Coat Mafia in about August 1998 after Morris threatened to beat-up and kill Perry. Perry denied any of the Trench Coat Mafia members made any bombs or explosive devices while he was associated with them.

On April 26, 1999 Investigator Estep and Attorney General Special Investigator Gary Clyman interviewed Robert Perty, who resides at 7836 South Newland Street, County of Jefferson, State of Colorado. Perry further detailed his day on April 20, 1999. Perry stated he recently obtained a job at Safeway on Ken Caryl and South Pierce Street, working a grave yard shift. So as not to interrupt his sleep patterns Perry stayed awake from April 19, 1999 to April 20, 1999. Perry stated between 8:00 and 11:00 a.m. on April 20, 1999 he talked with his Grandmother who resides at his home address. Perry stated at 11:00 a.m. he went to his basement bedroom and went to sleep. Perry stated that at 11:40 a.m. his mother woke him up by stomping on the kitchen floor directly above Perry's room. Perry went upstairs where his mother told him what she had heard on the news about the Columbine High School shooting. Perry left his residence at 12:00 p.m. to walk to Columbine High School to check on the welfare of his younger sister Lydie Perry. Perry advised about 12:15 p.m. he met up with his father Jim Perry; who had left work and was driving a possible route Lydie Perry may have driven. They returned home and received a call stating that Lydie Perry was at the Columbine Public Library, where they were able to pick her up.

On April 29, 1999 Jefferson County Investigator Jack McFadden interviewed Courtney Haulman, a student at Columbine High School. Haulman stated on April 20, 1999 at about 11:17 a.m., she was sitting on the concrete outside the south doors of the cafeteria at Columbine High School when she heard three gunshots. Haulman stated she walked to the southwest corner of the cafeteria and pecked around the corner at which time she saw three gunmen on the west steps leading to the west entrance.

Your affiant is of lawful age and a sworn peace officer of the Jetterson County Sheriff's Office, Golden, Colorado, in the County of Jefferson.

Your affiant states that the following facts are true and based upon his/her personal knowledge, as a result of his/her conversations with the person(s) named herein and reviewing their written reports.

On April 20, 1999, at about 11:20 a.m., Jefferson County Sheriff's Dispatch received a 9-1-1 call reporting that there was a shooting in the parking lot at Columbine High School located at 6201 South Pierce Street, County of Jefferson, State of Colorado.

Upon arrival, Jefferson County Sheriff's Deputies Scott Taborsky and Eric Miller observed numerous students who were yelling and screaming as they ran out of the school. Deputies Taborsky and Miller also heard what they believed to be gunshots coming from inside the school. Deputies Taborsky and Miller were told by numerous students that people had been shot inside the school.

Your affiant subsequently learned that 15 individuals were killed within Columbine High School during the incident as the result of gunshot wounds. Your affiant further learned that two of the decedents, Dylan Bennet Klebold, dob/09-11-81, and Eric David Harris, dob/04-09-81, were suspected of shooting 13 decedents, and had injured approximately 25 other students.

On April 20, 1999, Jefferson County Sheriff's Investigator Ralph Gallegos interviewed Christopher Morris, dob/06-09-81, shortly after the shootings at Columbine High School. Christopher Morris told investigator Gallegos that he used to be part of the "Trench Coat Mafia" (TCM), and that he believed the people inside of Columbine High School doing the shooting were Dylan hold, Eric Harris, and Morris said Klebold, Harris, and Morris also members of the Trench Coat Mafia. Morris further told Investigator Gallegos that Eric Harris goes by the name of "Reb." Morris told Investigator Gallegos that two weeks prior to April 20, 1999, Eric Harris had been picked on by "jocks" at Columbine High School. Shortly after this incident, Christopher Morris was at Dylan Klebold's house with Eric Harris and Harris said, "Wouldn't It be nice to kill jocks?"

Jefferson County Sheriff's Investigator Ralph Gallegos interviewed Alejandra Marsh, a student of Columbine High School, Marsh stated that she had been in class in Columbine High School, when she heard shooting. Marsh went to the corridor where she saw Dylan Klebold and a male known to her as "Reb." Marsh stated that both "Reb" and Dylan Klebold were wearing black pents and full length black dusters. Marsh saw that Dylan Klebold was carrying a rifle type weapon at waist height and was firing down the hall.

Littleton Police Detective Russell Hoffman interviewed Tyler Jackman, a student at Columbine High School. Jackman stated that he was in the parking lot of Columbine High School with a friend, Wade Alan Frank, at lunch time, about 11:30 a.m.. Tyler Jackman saw Dylan Klebold at the top of the stairs at the entrance to Columbine High School, wearing a full length black coat. Dylan Klebold walked down the stairs where an unknown male was lying face down at the bottom of the stairs. Tyler Jackman saw Dylan Klebold shoot into the back of the unknown male with a sawed off shotgun. Dylan Klebold then began walking toward a grassy area, at which point he took a white pipe bomb, lit it, and threw it into the senior parking lot, where it exploded, Dylan Klebold then walked back up the stairs where he met another male and the two walked inside the school. Tyler Jackman stated he could not identify the second male, as he only saw him briefly.

Haulman described the first as a white male, seventeen years old, 6'3", medium build, long dark outly hair, wearing a black trench coat, dark colored pants, carrying a long gun, with no hat. Haulman described the second gunman as a white male, sixteen to seventeen years old, shorter than the first gunman, medium build, no hat, no mask, dark clothing, black trench coat, with dark colored "grenade type things" hanging on his shirt. Haulman stated she had seen gunmen one and two in Columbine High School prior to April 20, 1999. Haulman described the third gunman as a white male, with a black trench coat, white shirt, carrying an odd shaped thing. Investigator McFadden showed Haulman three photo line-ups. Haulman identified from one line-up as the first gunman. Haulman identified Dylan Klebold from a second line-up as the second gunman. Haulman could identify no one from the third line-up.

On April 30, 1999 West Metro Drug Task Force Investigator Mike Russell interviewed John Ungerland, a student at Columbine High School. Ungerland stated that on April 20, 1999 at about 2:30 p.m. he saw a red Geo Metro in a subdivision south of Columbine High School, with two occupants. Ungerland stated that he believed the driver to be Ungerland stated the passenger was leaning out of the passenger window with a handgun. Ungerland stated that both occupants were dressed in black. Ungerland stated the passenger was a white male with long dirty blond hair.

On April 30, 1999 CBI Agents Jerry Means and Ricky Mundine interviewed Bijen Monte, a student at Columbine High School. Monte stated she went to the school store, adjacent to the cafeteria, purchased her hunch, and then went outside through the south commons door. Monte thought she saw fireworks sparkling on the sidewalk, then saw a guy in a trench coat coming down the hill. Monte recognized the male as who she hangs out with almost everyday, since January 1999. Monte stated that on a scale of one to ten, ten being positive, she estimated the identification to be eight and a half to nine. Monte stated had a black gun, about fifteen to eighteen inches long, hanging from his neck on a strap, which looked like a machine gun. he stated was wearing a black trench coat, a black baseball hat backwards, and had a long face and neck, a narrow chin, nooked teeth with an obvious overbite, lots of sone and indentations on his face, with a black t-shirt with white print, a red colored cloth attached to the left side of his waist, black tighter fitting jeans, black high top tennis shoes. Agent Means showed Monte a photo line which included a photo of Monte picked out of the photo line up and stated that he was the one she saw with the gun.

On May 3, 1999 Jefferson County District Attorney's Investigator Mike Heylin interviewed Crystal Archuleta, a student at Columbine High School. Archuleta stated that on April 20, 1999 she was eating lunch at Columbine High School on the cast window ledge, that is south of the student store, adjacent to the cafeteria. Archuleta noticed a girl outside fall to the ground. Archuleta thought the girl fainted and went to assist her. Archuleta noticed a chest wound and a "pile of blood". Archuleta heard several gunshots and looked up the hill by the stairs outside the cafeteria. Archuleta saw a brief profile of a male who was tall, wearing a black trench cost, a black ball cap on backwards, and black warm-up-type pants with black high top tennis shoes. Archuleta stated that she later identified the male from her yearbook as

On May 5, 1999, Attorney General Investigator Gary Clyman interviewed Ginette Cochrane, the grandmother of Robert Peny. She has resided at the Peny residence, 7836 South Newland Street, County of Jefferson, State of Colorado, since November 1998, and her bedroom in the house is located adjacent to the family room one level above where Robert Peny's room is located, which is in the basement. Cochrane stated that on April 20, 1999, she swoke at approximately 8:00 s.m. and shortly thereafter was

joined in the kitchen by Robert, who had been in his bedroom. They talked until about 9:00 a.m., at which time Robert returned to his bedroom. Later in the morning, at a time uncertain, Ms. Cochrane was joined in the kitchen by her daughter (Robert Perry's mother), Lydie Perry. While watching television at or about 11:45 a.m. Cochrane and Lydie Perry became aware of the incident occurring at Columbine High School based upon televised news breaks.

Cochrane told Inv. Clyman they then awoke Robert by pounding on the floor above his bedroom, and he came upstairs and appeared to Ms. Cochrane as if he had been asleep. Although Robert wanted to go to Columbine High School to check on the safety of his younger sister, Lydie Perry, he remained at the house until his father arrived and they left for the school at or about 12:30 p.m. According to Cochrane Robert remained with the family the remainder of the day.

Ms. Cochrane also stated that Robert typically wears clothes of the following description: Black or blue jeans, Black t-shirts with designs/lettering in yellow, red or blue, White t-shirts, Tennis shoes, either all black or gray/black (size 14), Black dress hat belonging to his father, James Perry, Ball caps, described as dark blue, some with Bronco emblems, usually worn backwards, A black trench coat.

On May 5, 1999 FB1 Agent Mark Holstlaw interviewed Lydie Jeanine Perry, the mother of Robert Perry. Lydic Perry said that Robert Perry went to bed on April 20, 1999, between 2:00 a.m. and 3:00 a.m. Lydie told Holstlaw that Robert Perry got up later that morning at approximately 11:30 am because she recalls Robert talking with his grandmother, Ginette Cochrane. Lydie Perry said she believes Robert Perry went back to his bedroom shortly after that. Lydie Perry said that at approximately 11:45 am she and Cochrane began seeing the news reports of the Columbine High School (CHS) shooting. She immediately yelled at Robert bory to get out of bed and he came-up from his room dressed only in a blanket.

wopert Perry then got dressed and wearing his black trench coat departed their residence to go check on his sister, who is a student at Columbine High School. Lydie Perry said she telephoned her husband, Jim Perry, who came home and as he traveled home, he ran into Robert Perry before he reached the school and drove him back to their house.

On April 24, 1999, Investigator Cheryl Zimmerman viewed three 8mm tapes which were taken by your affiant in a search warrant of Eric Harris' residence, on April 20, 1999. All three of the tapes include planning by Eric Harris and Dylan Klebold of the Columbine shooting incident, and their philosophies. At no time during any of the tapes do either Harris or Klebold indicate that anyone else is involved in the planning, or will be present and included as gunmen for the April 20, 1999, incident.

Your affiant has viewed photographs of both Robert Perry and Dylan Klebold, and knows them to be similar in appearance. Robert Perry is a white male, 6'02", slender build, with medium brown wavy hair, close to shoulder length. Dylan Klebold is a white male, 6'03", slender build, with medium brown wavy hair, also close to shoulder length. Both meles are known to frequently wear black trench costs, black baseball caps backwards, and to be associated with or involved with the Trench Cost Mafia. On the day of the incident Klebold was found to be wearing black BDU type pants, a black t-shirt with "Wrath" in red across the front, a black baseball hat with a "B" on the back worn backwards, black military style lace-up boots. On the day of the incident Harris was found to be wearing black BDU type pants, a white t-shirt, a thick webbing type harness over his shoulders, black military style lace-up boots. One black treach coat was found in the library and one found outside the doors at the top of the stairs.

On 05/15/1999, the following investigation was conducted by SA MARK HOLSTLAW and INVESTIGATOR DONALD ESTEP/ DNJTTF-DT.

At 4:30 p.m. INVESTIGATOR GARY CLYMAN, Colorado Attorney General's Office, SA HOLSTLAW and INV ESTEP, arrived at 7836 So Newland St. Littleton, Co., where a pre-arranged meeting with Mr. and Mrs. PERRY, ROBERT PERRY and their attorney, THOMAS J. HAMMOND. The meeting was set to obtain a Consent to Search for their residence.

At 5:51 p.m. Mr. PERRY signed the, JEFFERSON COUNTY SHERIFF'S OFFICE, (JCSO) CONSENT TO SEARCH AND SEIZE form, after discussions with his attorney and law enforcement officers and the search was commenced.
