Can you get me an estimate on shipping an OSCOR with MDC-2100 and and OTK-4000 to Tashkent (city name) in Uzbekistan (the street address is: 10, Kirk klz str.). Yes, I know that you might have to poke around to find an MDC, but this has already paid for the goods (some time ago), and there was an issue with their initial end-user letter, which hopefully is not resolved.
